- 1. Master Plan Approval 2009-2010
  - a. Letter to every household in the community, November 9, 2009
  - b. Letter to adjacent communities, November 12, 2009
  - c. First Charette, Saturday, November 21, 2009
  - d. Second Charette, Friday and Saturday, January 8 & 9, 2010 this report includes the cycle track proposal
  - e. Third Charette, Thursday, April 8, 2010
  - f. Presentation of Plan at the Roland Park Civic League Annual Meeting, Wednesday, May 19, 2010
  - g. June, 2010 Master Plan reviewed by the Baltimore City Planning Department
  - h. February 17, 2011 Master Plan approved by the Baltimore City Planning Commission
  - i. Master Plan process covered in 10 separate articles in the Baltimore Messenger in 2009-2010
  - j. Master Plan reports and recommendations have been available on the Roland Park website since 2010
- 2. Fall 2014 Baltimore City DOT approaches RPCL about possibility of installing a cycle track on Roland Avenue as part of the paving project
- 3. January 7, 2015, RPCL board approves the concept of a cycle track
  - a. DOT to meet with other stakeholders
  - b. DOT to hold a public meeting for the wider community
  - c. DOT schedules their meeting for April 29,2015, but it has to be postponed due to safety concerns
  - d. RPCL invites DOT to address the cycle track at the annual meeting
  - e. May 2015, all homeowners receive a letter inviting them to attend the annual meeting, with an agenda that includes the Roland Avenue paving project and the cycle track
  - f. April 3, 2015 E-letter reminds residents to attend the annual meeting, and states the agenda will include paving and cycle track
