- We are evaluating all information in an effort formulate recommendations that will be presented to the RPCL and will be provided to the City for its consideration


Survey Approach












Overall safety has improved on Roland Avenue due to the cycle track.












I support changing Roland Ave. to a single traffic lane each way, as a traffic calming measure with more space for bikes & parking.

Breaking Down the Numbers


- 353 unique responses
- 16 responses for single lane with cars against curb
- 11 responses for single lane with cycle track against the curb

Some Unique Responses

- Cars to Curb
- Parking at curb and cycling between parked cars and traffic
- Something similar to the way it is now with some modification to the cycle track
- Have a bike path only on the south direction and make it bidirectional.
- Keep two travel lanes for cars.
- Go back to the original Roland Ave. it was the safest road in the city for cycling because of the width of the parking/cycling lane. I ride a lot and no longer use Roland Ave to ride. I think it is much more dangerous for cyclists and for pedestrians.



Concerns by Most Common Words

335 out of the 503 Respondents added comments

- Approximately 200 responses mention: safety, risk and dangerous.
- Approximately 150 responses mention: parking
- Approximately 100 responses mention: debris, snow, leaves
- Approximately 60 responses mention: speed

Some Representative Individual Responses

- Thank you for the hard work on this. Designating space for cyclist is important to our community
- An unfortunate situation. BAD for Morale!
- I love the concept but the design is flawed
- We must consider Safety for all users of the road not just cyclists
- The cycle track advances Baltimore as a 21st century city
- This is a 21st century idea added to a 19th century street design, so no surprise it does not work
- The present design traps bicyclists in a narrow lane with no room to avert obstacles
- This design is only partial protection for cyclists
- Like the idea but with congestion at school times I'm uncomfortable with my children using it
- This is a disaster for handicapped citizens
- Glad to see the community outreach now, I wish it could have been done during the design phase.
- Allow children who cycle to school to use the sidewalks during limited hours
