



Advocacy

- Supported surrounding neighborhoods in their suit against Overlook property in already congested area
- Joined these same neighbors in appealing for a more favorable long term ruling on Overlook
- *Joined surrounding neighbors in requesting Falls Road/Northern Parkway traffic study including improved walkability, crossing, and cycling.
- Successfully navigated an MOU for Cross Keys redevelopment, again with collaboration between RPCL, Cross Keys condos, Cross Keys Maintenance Corp.



Advocacy

- Participated with boards of Wyndhurst and RPCF in Courageous Conversations seminar on race
- Strong Schools Maryland, Thread, and BUILD invited to present at RPCL board meetings and encouraging community participation
- Supported neighbors who developed Roland Park Self Quarantine Support Network
- Accepted funds from disbanded library group to support children's programming at RP public library



Advocacy

- Supported legislation for 83 patrols by State Police
- Extensive Plat rep outreach for email lists
- Support of RP Baseball League including their Fall Classic which helps fund financially strapped teams in our city.
- Donated to the food drives of groups who were new to the Eddie's program this year.

Committee Update:

- Committee meets 6-8 times annually to review current expenses and balance the budget
- 2019 2020 Income & Expenses in line with proposed budget
- Continued focus on ways to increase dues paid by ALL residents
- CL Cash Reserve balance has an operating account to fund 4 ½ years based on current expenses



Civic League Dues "Defined":

Regular Members:

- Regular membership dues \$40 Cost
- Individuals eighteen (18) years of age or older who reside or own real estate in Plats 1-6 of Roland Park
- Regular membership entitles a household to one vote

Associate Members:

- Associate membership costs \$10
- Must be eighteen (18) years of age or older
- Entitled to one additional vote

Billed Annually:

- 2020 2021 CL dues & RM fee billing mailed out in early April 2020
- ❖ 10% of Civic League Dues are allocated for donations annually from the Roland Park Civic League
- Contributions made from members of our community help offset the shortage
 - Helps contribute funds for those who may need financial assistance due to COVID 19 or other reasons
 - Thank you for your generosity and compassion for your neighbors and community!



CL Budget: How did 2019-2020 Look?

Pros:

- Annual dues collected year over year increased by \$850
- Increase in investment income
- * Balanced Budgets
 - > Excess Income Received + \$550
 - > Additional Expense Savings + \$3,170

Cons:

- Annual dues collected vs. budget decreased by \$280, 1.5%
- Anticipation for a potential decrease in miscellaneous income due to potential financial constraints related to COVID-19
- RPCL made a capital contribution to R & M for emergency Path repair work

- ❖ 2020 2021 Revenue Goal: \$34,220
 - Increase # of paying members by 100 households
 - Increase Revenue ~\$4,500
- Dues Collected as of May 3rd, 2020:
 - 109 Single + 138 Dual Household Memberships (~29%) = \$11,260
 - \$22,960 to go to reach our annual goal
 - 1/3 Processed through PayPal

Roads & Maintenance Mission & Fees "Defined":

RPRM Mission & Purpose:

- It enforces covenants, collects maintenance fees mandated in each property's deed and owns the network of footpaths.
- Maintenance of the footpaths and other common areas is the responsibility of the Civic League's Maintenance Committee.

Fees:

- Full Service Fee (Recommended):
 - 8x the required Basic Fee to reflect the cost of current expenses
 - Fee Covers:
 - Organic Debris Service 4x per year
 - Residential Tree Planting free tree 1x per year
 - Maintenance of Alleys (snow removal only)
 - Walking Paths, Islands and Small Parks
 - Maintenance Service Includes
 - Path Maintenance
 - Mowing & Plantings
 - Diseased tree removal on common land
 - Repairs and improvements to common property
 - $\ \, \ \, \ \,$ All residents benefit from services funded by the full service fee, and ...
 - ALL are encouraged to participate at this level!!!
- Basic Fee (Required):
 - Also called our "maintenance tax" set by the Roland Park Company at the turn of the century
 - Basic fees have remained unchanged since inception
 - > This fee is specified in all original deeds and is required of all property owners in perpetuity
 - > Roland Park Pool Membership must be current on all dues to join the pool
- Delinquent Fee:
 - ❖ Basic Fees not paid from prior years are deemed to be delinquent
 - Roads and Maintenance generally files a lien on properties if fees are delinquent for more than two years



RM Budget: How did 2019-2020 Look?

Pros:

- Annual dues collected year over year increased by \$1,283
- Net income losses have decreased ~50% consecutively over the past 3 years \$14k net income loss → \$4k
- Expense Savings
 - > \$2,500 in overall Expense vs. Budget
 - ➤ No snow = No Plowing = Expense Savings

Cons:

- Annual dues collected vs budget decreased by \$1,682
- Organic Debris Expenses
 - ➤ Increased \$5,500 year over year
 - > \$3,200 spent over budget
 - Extensive analysis concluded the need to reduce the program from 8 to 4 pick-ups per fiscal year for <u>FULL</u> paying residents
 - ~\$10,000 annual savings for community projects
- RPCL \$4,000 Capital Contribution to Maintenance Budget for an emergency path repair


- * 2020 2021 Revenue Goal: \$124,500
 - Increase # of paying members by 50 households
 - Increase Revenue ~\$6,500
- ❖ Fees Collected as of May 3rd, 2020:
 - ~300 Household Memberships (~29%) = \$44,000
 - \$80,500 to go to reach our annual goal
 - Potential to increase fees by ~ \$115k if <u>ALL</u> residents paid their <u>FULL</u> fees



Roads and Maintenance Report

Highlights

- The facade and wood trim on the shopping center were repaired and painted. Window replacements were completed and the windows have been painted.
- One Plat 5 property signed a new covenant.
- Due to coronavirus restrictions, the Board is currently reviewing applications by email.
- * Tom Carlson's term as President expired. John Morrel is the new President.



Roads and Maintenance Report

APPLICATIONS 4/26/19 - 5/16/20

- *75 applications were received.
- *69 applications were approved, some with suggested revisions, some with resubmissions.
- *4 applications are pending.
- *1 application for new lighting at the Shopping Center was not reviewed due to lack of details.
- *1 application was rejected with recommendations for acceptable modifications – waiting for a revised application.



PROPERTIES UNDER COVENANT

- *99.6% of the 282 Plat 1 properties have covenants which are part of the original deeds from RP Co.
 - These covenants do not expire.
 - Most deeds prior to mid-1901 do not include a requirement for approval of alterations or additions.
 - One property predates the creation of Roland Park.



PROPERTIES UNDER COVENANT

- ❖75% (547/729) of properties in Plats 2 6 are under modern renewal covenants which run with the land.
- *All properties under covenant in Plats 2-6 require review and approval by R&M of alterations and additions.
- In total, 82% (828/1012) of properties in Roland Park are under covenants.
