	The state will begin its review starting the week of 6/6

Discussion on Equity and Inclusion in Roland Park	At large board member Martha Holleman presented slides on DEI in RP; the presentation is the output of conversations originating with the executive board, several Master Planning Committee Members and neighbors. Members from the effort with Hillside park conveyed various ways in which
	they are including the broader community in the design, planning, and activities for the park keeping equity at the forefront of the effort; the Hillside Park group is considering continuing its awareness and fundraising activities
	There was a robust conversation around equity, diversity and inclusion within the community and the RPCL's role in facilitating increase in those areas
	The group presenting discussed feedback to their recommendations and the need to present a specific charge or scope for any future efforts to be formally supported by the RPCL; or alternatively, to outline action items to be taken by neighbors
Landscape Committee	The delivery of park benches is delayed due supply chain issues; exp. in June
	Native plants have been installed at the Parking Garage
	Tree planting efforts continue and the Committee will continue to provide news throughout the summer
