Genie Arnot – Social Studio	Owner and teacher at Social Studio, 737 Deepdene Rd. Her classes focus on the creative process through empathy and connection. She was joined at the meeting by Whitney Frazier, Community Art Projects. They are planning to paint a mural on the Starbucks wall. The corner is a meeting place for so many facets of the community. They want to take into consideration the history and foundation of RP, in that it was not designed to be inclusive. Look toward being intentional about inclusivity to counter the history of RP, even though the actual location of that Starbucks is Tuxedo Park. Design meetings from participants - Goal is to have a mural that reflects the values of the community. She pointed out that the process of deciding has as many benefits as the product itself. She shared the 3 ideas for the mural; the RP board unanimously favored the 2nd on, the most whimsical. Ms Arnot would like some community feedback. She will share her wonderful slides about her plans on social media. Kathy Hudson asks if she could share her slides with the landscape committee as it melds with their mission/work.

	3) Recreating the infrastructure of the office – assistant case (state) attorneys have been gutted. Hire and train them.	
	4) New thing is the Older Adult Division – looks out and protects elders. Scams. etc. Protect them in homes.	
	5) Community Court Watch – app. See crimes and the court info and outcome.	
	They welcome community impact statements – you can fill out to let them know about your reactions to judgements. Learn how the neighborhood felt about the decision.	
	They sound out a weekly email. He will leave his card to get the updates.	
	Talk about cost - 10-15 thousand inclusive of soup to nuts. Lots of layers.
